



CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Agreement made, this ____ day of 2019, between **PHILIPPINE COUNCIL FOR AGRICULTURE, AQUATIC AND NATURAL RESOURCES RESEARCH AND DEVELOPMENT (PCAARRD)**, hereinafter referred to as the "**Procuring Entity**" and **IEQUITY TECHNOLOGIES, CORPORATION** hereinafter referred to as the "**Supplier**".

WHEREAS, Procuring Entity invited suppliers to bid for the "Supply & Delivery of ICT Equipment, Software, and Peripherals" published at PhilGEPS, PCAARRD website and other conspicuous places;

WHEREAS, SUPPLIER, submitted its bid under the Public Bidding conducted on August 2, 2019 and was found to have the lowest calculated and responsive bid on upon evaluation by PCAARRD's Bids and Awards Committee;

WHEREAS, Procuring Entity, has accepted the bid, in item nos. 1-12 amounting to **PESOS: TWO HUNDRED NINETY FOUR THOUSAND SIX HUNDRED PESOS ONLY (Php294,600.00)**.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, to wit:
 - (a) Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) Schedule of Requirements;
 - (c) Technical Specifications;
 - (d) General Conditions of Contract;
 - (e) Special Conditions of Contract;
 - (f) Performance Security; and
 - (g) Notice of Award.
3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


