This Agreement made, this ____ day of 2020, between **PHILIPPINE COUNCIL FOR AGRICULTURE, AQUATIC AND NATURAL RESOURCES RESEARCH AND DEVELOPMENT (PCAARRD)**, hereinafter referred to as the "**Procuring Entity**" and **COMMUNITY CABLE VISION CORPORATION (CCVC)**, hereinafter referred to as the "**Supplier**".

WHEREAS, Procuring Entity invited suppliers to bid for the Procurement of Last Mile Connection on November 12- December 2, 2019 published at PHILGEPS, PCAARRD website and other conspicuous places;

 - (b) Schedule of Requirements;
 - (c) Technical Specifications;
 - (d) General Conditions of Contract;
 - (e) Special Conditions of Contract;
 - (f) Performance Security; and
 - (g) Notice of Award.
3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


