This Agreement made, this _____ day of ______ 2020, between PHILIPPINE COUNCIL FOR AGRICULTURE, AQUATIC AND NATURAL RESOURCES RESEARCH AND DEVELOPMENT (PCAARRD) of the Philippines (hereinafter called as the "the Entity") of the one part and MOLINA'S GENERAL BUILDERS of 5230 Patimbao Ilaya, Sta. Cruz, Laguna (hereinafter called "the Contractor") of the other part:

WHEREAS the Entity is desirous that the Contractor execute Repainting, Waterproofing and Repair of Adjacent Roof Structures of A.R. Tanco Hall, E.O. Tan Hall, BPK Building and DPITC Building (hereinafter called "the Works") and the Entity has accepted the Bid for One Million Nine Hundred Thirty Eight Thousand Eight Hundred Seventy Two Pesos and 38/100 only (PhP1,938,872.38) (hereinafter called "the Contract Price") by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
 - (a) the General and Special Conditions of Contract;
 - (b) the Drawings/Plans;
 - (c) the Specifications;
 - (d) the Invitation to Bid;
 - (e) the Instruction to Bidders;
 - (f) the Bid Data Sheet;
 - (g) the Addenda and/ or Supplemental/ Bid Bulletins, if any;
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto; and
 - (I) Other contract documents that may be required by existing laws and/or the Entity.
- In consideration of the payments to be made by the Entity to the Contractor as
 hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and
 complete the Works and remedy any defects therein in conformity with the provisions of
 this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times in the manner prescribed by this Contract.
