

RESOLUTION NO. G-18-31E

BAC Resolution Declaring LCRB and Recommending Approval

WHEREAS, the Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD) advertised the Invitation to Bid of the project **"Printing of PCAARRD Publications (FY 2019)"** with an Approved Budget for the Contract (ABC) amounting to ONE MILLION TWO HUNDRED THOUSAND PESOS ONLY (PhP1,200,000.00) at the PCAARRD Website, Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in the Municipality of Los Baños from October 13, 2018;

WHEREAS, in response to the advertisement, only Color1Digital, Inc. participated in the pre-bid conference on October 22, 2018;

WHEREAS, bidding documents from four bidders, namely: Color1Digital, Inc., Cover & Pages Corporation, Colorplus Production Group Corp., and Innovation Printshoppe, Inc., were received for the opening of bids on November 5, 2018;

WHEREAS, during the opening of technical documents, representative of Innovation Printshoppe, Inc. raised the issue of Colorplus Production Group Corp.'s non-inclusion of a sheet of paper for Joint Venture Agreement (JVA) stating "Not Applicable";

WHEREAS, Mr. Argana, BAC Vice-Chairperson, explained that non-inclusion of the said document also means that it is not applicable and violation may only occur if the bidder will enter in a joint venture agreement later on;

WHEREAS, representative of Innovation Printshoppe, Inc. respected and concurred with the decision of the BAC;


WHEREAS, the four bidders were found eligible with financial proposals (as read) as follows:

WHEREAS, upon post-qualification of the Technical Working Group (TWG) for IEC, Color1Digital, Inc. with the lowest calculated bid for Lot A, and Colorplus Production Group Corp. with the lowest calculated bid for Lot B and C were found to have complied with and responsive to all the requirements and conditions in the bidding documents;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare **Color1Digital, Inc.** as the bidder with the lowest calculated responsive bid for Lot A in the amount of **THREE HUNDRED SEVENTY FIVE THOUSAND PESOS ONLY (PhP375,000.00)**, and **Colorplus Production Group Corp.** as the bidder with the lowest calculated responsive bid for Lot B and C in the amount of **SEVEN HUNDRED TEN THOUSAND FOUR HUNDRED PESOS ONLY (PhP710,400.00)** and to recommend to the Executive Director of PCAARRD the award of contract at its respective bid price.


