WHEREAS, the Management Information Systems Division (MISD) on its letter dated September 24, 2019 requested for the procurement of six (6) units Desktop Computer through Section 51 - Repeat Order of the 2016 Revised IRR of RA 9184 as the mode of procurement which was approved by Dr. Eboras as the Head of the Procuring Entity;

WHEREAS, the procurement of the said ICT equipment will be used by regular employees hired last 2018-2019;

WHEREAS, the said items were not included in the previous procurement through public bidding because earlier estimates could not cover the cost, and the budget for these items became available as savings after the bidding was concluded;

WHEREAS, the repeat order was resorted as it complied with the following conditions:

1. Items were previously awarded to Joneco Tech. Marketing Corp through public bidding;
2. Unit price is the same in the original contract;
3. It is not the result of splitting of contracts;
4. It is availed within six (6) months from the date of Notice to Proceed which was signed on July 18, 2019, and had been delivered, inspected, and accepted on July 19, 2019; and
5. The quantity does not exceed 25% of the quantity of the item awarded in the original contract as stated below:
