WHEREAS, the Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD) advertised the Invitation to Bid of the project **"Supply and Delivery of ICT Equipment and Peripherals"** with an Approved Budget for the Contract (ABC) amounting to SIX HUNDRED FORTY FIVE THOUSAND ONE HUNDRED PESOS ONLY (Php645,100.00) at the PCAARRD Website, Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in the Municipality of Los Baños from September 24 to October 14, 2019;
