BAC Resolution Declaring Failure of Bidding

WHEREAS, the Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD) advertised the Invitation to Bid of the project "**Procurement of IP-PBX Equipment and Support Service**" with an Approved Budget for the Contract (ABC) amounting to SIX HUNDRED THIRTY ONE THOUSAND SIX HUNDRED EIGHTY PESOS ONLY (PhP631,680.00) at the PCAARRD Website, Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in the Municipality of Los Baños from November 12 to December 2, 2019;

WHEREAS, Community Cable Vision Corp., PLDT, Inc., Globe Telecom, and iEquity Technologies, Corp. participated in the pre-bid conference on November 20, 2019;

WHEREAS, bidding proposal from PLDT, Inc. was received for the opening of bids on December 2, 2019;

WHEREAS, PLDT, Inc.'s submission for its Single Largest Completed Contract (SLCC) included two projects specifically in PCAARRD and Bureau of Animal Industry (BAI); however, it was found non-complying due to absence of supporting documents for the project in PCAARRD, and the date of completion was beyond the duration specified in the bidding documents for the project in BAI;

WHEREAS, in addition, there was no submission of its latest Income and Business Tax Returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) as part of the required eligibility requirements;

WHEREAS, based on the above statement, the bidding is declared a "failure" following Rule X – Post-Qualification, Section 35. Failure of Bidding;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare the bidding a failure and to recommend the conduct of mandatory review and evaluation of the terms and conditions, specifications, and cost estimates of the said project (Section 35.1 - 35.5 of RA 9184 and its IRR) for re-advertisement and rebidding purposes.


