BAC Resolution Declaring SCRB and Recommending Approval

WHEREAS, the Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD) advertised the Invitation to Bid of the project **"Supply and Delivery of Software Licenses"** with an Approved Budget for the Contract (ABC) amounting to **SIX HUNDRED THIRTY FOUR THOUSAND FOUR HUNDRED SIXTY EIGHT PESOS ONLY (PhP634,468.00)** at the PCAARRD Website, Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in the Municipality of Los Baños from November 12 to 20, 2019;

WHEREAS, in response to the advertisement, iEquity Technologies, Corp. submitted its bid proposals for the opening of bids on November 20, 2019;

WHEREAS, upon post-qualification of the TWG for ICT, iEquity Technologies, Corp. was found to have complied with and responsive to all the requirements and conditions in the bidding documents;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare the following: 1) iEquity Technologies, Corp. as the bidder with the single calculated responsive bid for Lot B in the amount of **THREE HUNDRED TEN THOUSAND NINE HUNDRED SIXTY PESOS ONLY (PhP310,960.00)** and to recommend to the Executive Director of PCAARRD the award of contract at its respective bid price; and, 2) bidding for Lots A and C a failure and to recommend the conduct of mandatory review and evaluation of the terms and conditions, specifications, cost estimates of the said items (Section 35.1 - 35.5 of RA 9184 and its IRR) for re-advertisement and rebidding purposes.
