BAC Resolution Declaring Failure of Bidding

WHEREAS, the Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD) advertised the Invitation to Bid of the project "Supply and Delivery of Audio Visual Equipment and Peripherals" with an Approved Budget for the Contract (ABC) amounting to FOUR HUNDRED TWENTY ONE THOUSAND TWO HUNDRED PESOS ONLY (PhP421,200.00) at the PCAARRD Website, Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in the Municipality of Los Baños from October 21 to November 11, 2019;

WHEREAS, no bidder participated in the pre-bid conference conducted on October 29, 2019;

WHEREAS, two bidders namely: Pinnacle Sphere Enterprises and iEquity Technologies, Corp. submitted their respective proposals for the bid opening on November 11, 2019;

WHEREAS, Pinnacle Sphere Enterprises was found to be non-complying due to absence of supporting documents for its Single Largest Completed Contract (SLCC) while iEquity Technologies, Corp. was also found to be non-complying due to absence of its Latest Income and Business Tax Returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) as part of the required eligibility requirements;

WHEREAS, Pinnacle Sphere Enterprises signified that they will be filing a request for reconsideration and the BAC Vice Chairperson responded that the Pinnacle Sphere Enterprises must submit it within three (3) calendar days upon verbal notification;

WHEREAS, no request for reconsideration was received from Pinnacle Sphere Enterprises until the third day;

WHEREAS, based on the above statement, the bidding is declared a "failure" following Rule X – Post-Qualification, Section 35. Failure of Bidding;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare the bidding a failure and to recommend the conduct of mandatory review and evaluation of the terms and conditions, specifications, and cost estimates of the said project (Section 35.1 - 35.5 of RA 9184 and its IRR) for re-advertisement and rebidding purposes.


