BAC Resolution Declaring LCRB and Recommending Award of Contract to PLDT, Inc.

**WHEREAS**, the Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD) advertised the Invitation to Bid for the project "Procurement of CY2025 Wired & Wireless Internet Connectivity" (IB No. 24-10-22-EPA), with an Approved Budget for the Contract (ABC) amounting to ONE MILLION FIVE HUNDRED THOUSAND PESOS ONLY (PhP1,500,000.00) at the PCAARRD Website, Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in the Municipality of Los Baños from October 9 - October 29, 2024;

**WHEREAS**, two (2) prospective bidders namely: 1) Royal Cablevision Corporation, and 2) PLDT, Inc. participated in the pre-bid conference on October 17, 2024;

**WHEREAS**, bid proposals from two (2) bidders namely: 1) Royal Cablevision Corporation, and 2) PLDT, Inc. was received for the bid opening on October 29, 2024;

**WHEREAS**, one bidder, Royal Cablevision Corporation, was disqualified during the bid opening due to non-compliance with the technical requirements;

**WHEREAS**, PLDT, Inc. was declared eligible with all the required documents with a financial bid amounting to PhP913,920.00;

**WHEREAS**, upon detailed evaluation and post qualification of the Technical Working Group (TWG) for ICT, PLDT, Inc. was found to have complied with and responsive to the requirements and conditions in the bidding documents;

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare **PLDT Inc.** as the bidder with the lowest calculated responsive bid for the Procurement of CY2025 Wired & Wireless Internet Connectivity in the total amount of **NINE HUNDRED THIRTEEN THOUSAND NINE HUNDRED TWENTY PESOS ONLY (PhP913,920.00)** and to recommend to the Executive Director of PCAARRD the award of contract at its respective bid price.
