BAC Resolution Declaring SCRB and Recommending Award of Contract
to Delsan Office Systems Corporation

WHEREAS, the Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD) advertised the Invitation to Bid for the project "Procurement of CY2025 Managed Print Service (MPS) (EPA)" IB No. 24-10-24-EPA, with an Approved Budget for the Contract (ABC) amounting to **TWO MILLION EIGHT HUNDRED FORTY-SEVEN THOUSAND PESOS ONLY (PhP2,847,000.00)** at the PCAARRD Website, Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in the Municipality of Los Baños from October 23 - November 20, 2024;

WHEREAS, one (1) prospective bidder namely: Delsan Office Systems Corporation participated in the pre-bid conference on November 4, 2024;

WHEREAS, a bid bulletin was issued on October 30, 2024;

WHEREAS, only one bid proposal from Delsan Office Systems Corporation was received for the bid opening on November 20, 2024;

WHEREAS, Delsan Office Systems Corporation was declared eligible with all the required documents with a financial bid amounting to PhP2,806,200.00;

WHEREAS, upon detailed evaluation and post qualification of the Technical Working Group (TWG) for ICT, Delsan Office Systems Corporation was found to have complied with and responsive to the requirements and conditions in the bidding documents;


