BAC Resolution Declaring SCRB and Recommending Award of Contract to MyBusyBee, Inc..

WHEREAS, the Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD) advertised the Invitation to Bid for the project "Procurement of CY2025 ICT Cloud-based Video Conferencing Software (EPA)" IB No. 24-11-27-EPA, with an Approved Budget for the Contract (ABC) amounting to FOUR HUNDRED SIXTY-EIGHT THOUSAND PESOS ONLY (PhP468,000.00) at the PCAARRD Website, Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in the Municipality of Los Baños from November 7 - November 15, 2024;

WHEREAS, no pre-bid conference was conducted;

WHEREAS, only one bid proposal from MyBusyBee, Inc. was received for the bid opening on November 15, 2024;

WHEREAS, MyBusyBee, Inc. was declared eligible with all the required documents with a financial bid amounting to PhP395,644.60;

WHEREAS, upon detailed evaluation and post qualification of the Technical Working Group (TWG) for ICT, MyBusyBee, Inc. was found to have complied with and responsive to the requirements and conditions in the bidding documents;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare **MyBusyBee, Inc.** as the bidder with the single calculated and responsive bid for the "Procurement of CY2025 ICT Cloud-based Video Conferencing Software (EPA)" in the total amount of **THREE HUNDRED NINETY-FIVE THOUSAND SIX HUNDRED FORTY-FOUR PESOS AND 60/100 (PhP395,644.60)** and to recommend to the Executive Director of PCAARRD the award of contract at its respective bid price.
