BAC Resolution Declaring SCRB and Recommending Approval
Award of Contract to Delta Maroon Security Agency Corporation

WHEREAS, the Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD) advertised the Invitation to Bid on the project "Procurement of CY2025 Security Services" with an Approved Budget for the Contract (ABC) amounting to SEVEN MILLION FIVE HUNDRED TWENTY THOUSAND THIRTY-FOUR PESOS AND 60/100 (PhP7,520,034.60) at the PCAARRD Website, Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in the Municipality of Los Baños from December 28, 2024 to January 22, 2025;

WHEREAS, a pre-procurement conference was conducted on November 15, 2024;

WHEREAS, four prospective bidders, (1) Millanes Security Agency Incorporated, (2) Delta Maroon Security Agency Corporation, (3) Urduja Security Services Inc., (4) DGreat Stallion participated in the pre-bid conference on January 10, 2025;

WHEREAS, bid bulletin no. 1 was issued on January 6, 2025 and bid bulletin no. 2 was issued January 15, 2025;

WHEREAS, only one proposal from Delta Maroon Security Agency Corporation was received for the bid opening on January 22, 2025;

WHEREAS, Delta Maroon Security Agency Corporation was declared eligible with all the required documents with a financial bid amounting to PhP7,458,887.70;

WHEREAS, upon detailed evaluation and post qualification of the Technical Working Group (TWG) for General Services, Delta Maroon Security Agency Corporation was found to have complied with and responsive to the requirements and conditions in the bidding documents;

WHEREAS, Delta Maroon Security Agency Corporation has received an "Outstanding" and "Excellent" rating from DOST-PCAARRD and Tarlac Agricultural University (TAU).
