

# CONTRACT AGREEMENT

23 JAN 2019

This Agreement made, this \_\_\_\_ day of \_\_\_\_\_ 2019, between **PHILIPPINE COUNCIL FOR AGRICULTURE, AQUATIC AND NATURAL RESOURCES RESEARCH AND DEVELOPMENT (PCAARRD)** of Los Baños, Laguna (hereinafter called "the Entity") of the one part and **Color1Digital, Inc.** of Makati City (hereinafter called "the Supplier") of the other part:

**WHEREAS**, the Entity invited Bids for certain goods and ancillary services, viz., Printing of PCAARRD Publications (FY 2019) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **THREE HUNDRED SEVENTY FIVE THOUSAND PESOS (P375,000.00)** (hereinafter called "the Contract Price") for Lot A.

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


