CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Agreement made, this 15 JUL 2019 day of 2019, between **PHILIPPINE COUNCIL FOR AGRICULTURE, AQUATIC AND NATURAL RESOURCES RESEARCH AND DEVELOPMENT (PCAARRD)**, hereinafter referred to as the "**Procuring Entity**" and **JONECO TECH MARKETING CORP.** hereinafter referred to as the "**Supplier**".

WHEREAS, Procuring Entity invited suppliers to bid for the Supply and Delivery of ICT Equipment and Peripherals on April 2-22, 2019 published at PhilGEPS, PCAARRD website and other conspicuous places;

WHEREAS, SUPPLIER, submitted its bid under the Public Bidding conducted on April 22, 2019 and was found to have the lowest calculated and responsive bid on Lot A upon evaluation by PCAARRD's Bids and Awards Committee;

WHEREAS, Procuring Entity, has accepted the bid, in lot price amounting to **PESOS: TWO MILLION TWO HUNDRED FIFTEEN THOUSAND SEVEN HUNDRED NINETY SIX PESOS & 80/100 (Php2,215,796.80)**.

 - (f) Performance Security; and
 - (g) Notice of Award.
3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
