





**CONTRACT AGREEMENT**

This Agreement made this January 3 day of 2022, between PHILIPPINE COUNCIL FOR AGRICULTURE, AQUATIC AND NATURAL RESOURCES RESEARCH AND DEVELOPMENT (PCAARRD) of the Philippines (hereinafter called "the Entity") and DBP Service Corporation of Makati City, Philippines of 2<sup>nd</sup> Floor, Executive Bldg. Center, Gil Puyat corner Makati Avenue, Makati City, Philippines (hereinafter called "the Supplier") of the other part.

WHEREAS, the Entity advertised the Invitation to Bid of the project "Engagement of Third-Party Manpower Service Provider" with an Approved Budget for the Contract (ABC) amounting to SEVENTY MILLION, NINE-HUNDRED EIGHTY THOUSAND EIGHT HUNDRED NINETEEN & 98 (70,980,819.98) at the PCAARRD Website, Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous in the Municipality of Los Baños from November 16 to December 6, 2021.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
