CONTRACT AGREEMENT

THIS AGREEMENT made this 10 day of May COUNCIL FOR AGRICULTURE, AQUATIC AND NATURAL RESOURCES RESEARCH AND DEVELOPMENT (PCAARRD) of Los Baños, Laguna, Philippines, hereinafter called "the Entity" and RCJ Trading and General Merchandise of 381 Brgy. Santo, Tanauan City, Batangas Philippines, hereinafter called "the Supplier";
