CONTRACT FOR THE SUPPLY AND DELIVERY OF CY2026 Q1 OFFICE SUPPLIES (EPA)

This CONTRACT executed on the 09 day of January 2026 by and between:

PHILIPPINE COUNCIL FOR AGRICULTURE, AQUATIC AND NATURAL RESOURCES RESEARCH AND DEVELOPMENT (PCAARRD), a government agency of the Republic of the Philippines, hereinafter called "the Entity";

-and-

RENEO TRADING, a company duly organized and existing under the laws of the Philippines, with principal office at Victoria Homes, Darasa Tanauan City, Batangas, hereinafter called "the Supplier/Contractor/Consultant".

WHEREAS, the Entity invited Bids for certain goods and services/works/consulting services, particularly ***Supply and Delivery of CY2026 Q1 Office Supplies (EPA) for Lot B***;
